TERMS OF MEMBERSHIP

1. As a member all published information used in Public Relations, Advertising, Bulk mailers, sms, WhatsApp or social media, to WOS members, must be approved at a head office level prior to publishing;
2. In the instance of dispute the code of conduct and terms of membership will take precedence. If there are any disputes, part of becoming a WOS member you agree to handle these confidentially with regard for the brand credibility;
3. In order to uphold the code of conduct and facilitate the values of WOS overselling, misrepresentation or any other predatory business practices that can harm anybody will subject the respective member to the disciplinary procedure of WOS which can result in the full termination of members without any refunds.
4. Please notify WOS of a change of address and contact details.
5. Where applicable, all valid artwork and advertisements for the website, must be provided by the member to the office as soon as possible and on members own account;
6. Members and/or their guests are obliged to RSVP for functions and events. In the event that the member does not attend or cannot attend the event, after a confirmation of attendance (RSVP) was sent, she is liable for the cost and payment due.
7. The Member accepts the policies, procedures and principles of Woman of Stature.
8. These terms and conditions as well as the policies, procedures and principles may only be amended as follows:
 - a. In the event of an amendment initiated by WOS,
 - b. WOS shall give all members 30 day written notice of the intended amendment. The amendment will then be effective upon the expiring of the said 30 days unless the member shall have given WOS written notice of her intention to dispute the amendment.

9. DOWNGRADE

- a. A member is entitled to downgrade their membership package.
- b. A membership can only be downgraded once in a 12 month cycle.
- c. The new membership package will therefore replace the old one and be activated for twelve months from the month of downgrade.
- d. This is only applicable to members who signed up on a monthly debit order.

10. UPGRADE

- a. A member is entitled to upgrade their membership package at any time, irrespective of whether they are on a debit order arrangement or paid annually.
- b. The new membership package will therefore replace the old one and be activated for twelve months from the month of upgrade.
- c. If the member is on a monthly debit order agreement, the new membership package will there replace the old package and activated for twelve months from month of upgrade
- d. If the member is on an annual payment, the new membership package will therefore replace the old package and be activated for twelve months from month of upgrade, after transferring credit for the remainder of the old package over to the upgraded package.
- e. FOR EXAMPLE
 - i. Gold R3267
 - ii. Renew to Platinum in month 5 of Gold contract, therefore there is 7 full months remaining. This means that R3267 divide by 12 is R272.25 per month, which means there is R1905.75 (7months) credit remaining. This amount can be deducted from the upgraded package, for example: R6567 – R1905.75 = R4662.25
 - iii. The member will be billed R4661.25 and the contract will renew in 12 month.

Membership Payment Terms

- 1) Members understand and acknowledge that they undertake to pay the fees as per the selected package and are payable by the undersigning of this agreement.
- 2) The membership term is valid from the month of approval and registration for twelve months, and automatically renewed for an annual basis for twelve months with an automatic escalation of the membership fees of 10%.
- 3) Written notice must be given at least 20 working days before annual renewal date should the member wish not to renew her membership.
- 4) Fees can only be paid by debit order except where membership is paid in full.
- 5) Where a member selects to pay by debit order, the joining fee and first month's membership fee is paid by EFT on receipt of invoice.
- 6) Membership cannot be terminated until the full term is complete.
- 7) Members Fees are inclusive of 15% VAT

Money back Guarantee

- 1) Within 7 days of signature the membership agreement can be reversed without consequences or penalties.
- 2) Within 90 days the member can request a full refund and cancel their membership.
- 3) Our 90 day money back guarantee is applicable to the membership fee but not the admin fee.
- 4) On condition that the member has fully engaged from the time of registration. Attended network events, submitted their details for listing on the directory.
